

## **Requirements for Requesting CTE Course Waivers at South Seattle College**

To stay in compliance as a Business and Industry Route initial CTE certification provider, South Seattle has to have documentation of proof of mastery for program competencies not earned through the South Seattle CTE Teacher Certification Program courses.

| • Legal Issues: Rights and Responsibilities<br>(Must provide an <u>official transcript</u> from the<br>College granting the teaching degree <b>and</b> a<br>copy of the educational law <u>course outline</u><br><u>you took</u> .)  | As part of your bachelor's and master's degree<br>completed a college level course (3 credits or<br>more) in <u>educational</u> law within the <b>last TWO</b><br><b>years</b> at a <b>Washington State college.</b> |

| •Integrating Technologies in the Classroom<br>(Must provide an <u>official transcript</u> from the<br>College granting the teaching degree <b>and</b> a<br>copy of the instructional technology <u>course(s)</u><br><u>outline</u> s.)   | As part of your bachelor's and master's degree completed a college level course in <u>instructional</u> <u>technology</u> .   |

| <ul> <li>Teaching Strategies</li> <li>Organization and Curriculum Design</li> <li>Classroom Management</li> <li>Instead of taking <i>Integrating Technologies in the Classroom</i> and <i>CTE Assessment &amp; Evaluation</i>, you will have the option of taking the course, <i>Program Development: Implementing CTE Standards</i>, developed for professionals who have been primarily in the teaching profession for the last seven years</li> </ul> | Possess a current WA State teaching certificate<br>AND<br>Currently teaching in a middle or high school<br>program in WA State for a minimum five years.<br>(Must provide a copies of your current WA State<br><u>Teaching Certificate and your conditional or</u><br><u>probationary CTE certificate</u> ) |

- To receive initial CTE certification from South Seattle, a student must complete a minimum of six classes in the CTE program at South Seattle.
- > All waiver requests must be in writing.
- > Requested documentation can be submitted via email, fax, mail or in person.
- The waiver request will not be considered until all the required documents have been received by the program manager in the Continuing Education office.
- The materials are reviewed by the program manager and a subcommittee of the CTE Professional Education Advisory Committee.
