• 1:15 – 2:05 p.m.: New year and budget planning discussion with President Rosie Rimando-Chareunsap

• President's Cabinet would like to partner with CC to co-host quarterly budget forums and monthly budget workshops throughout the year.

- o Main focus this year is, "Accountability & Transparency"
  - Rosie met with account managers across campus to better understand budget situation.
  - Reviewed FY1819 Management & Planning Activities spreadsheet

o Yilin: Are grants part of overall budget?

Rosie: Not part of overall budget, but open to more of these opportunities.
o Jeffrey: Are new grant writing positions being considered?

• Rosie: Not at the moment, but should be considered moving forward.

- Mac: Besides setting up forums, how else can CC help?
  - Rosie: Engagement, how do we involve the entire campus? Surveys, emails?
  - Jeffrey: Last year livestreams worked well to engage.
  - Look into using Zoom for this or another livestream app.

o Rosie: How do we involve students? What are they most concerned with?

- Yilin: Instructors want courses to be offered so students can progress faster.
- James: I work closely with Club Center, classes being cut last year was a blow to students.
- Jeffrey: Veteran students are in decline due to course closures, international students need courses to stay in the US, domestic students need courses to plan ahead to transfer.

• Seth: Need to put more pressure on our representatives to better fund our college.



• Rosie: Seattle Colleges working to establish regional pay, pushback from college leaders outside Seattle area.

- 2:05 2:35 p.m.: Discussion on transportation including viaduct closure and future of light rail and possible next steps
  - o Jeffrey: Lack of communication around upcoming transportation issues facing South.
    - USA members attended West Seattle Transportation Coalition (WSTC) meeting to discuss light rail extension.
  - o Joyce Allen: Decisions have already been made for future light rail extension.
    - 89% of campus community lives off peninsula.
    - Light rail coming to West Seattle in 2030, some monies being allocated from ST3.
    - South has not been a part of this dialogue, but final routes will be decided in February 2019.
    - South is the only major voice to bring light rail closer to Pigeon Point.
    - Light rail stop either at Andover St. or Genesee St.
  - Joyce: There is a need to inform campus community about viaduct closure. How do we inform the campus?
    - a. Invite DOT reps to campus to discuss closure.
    - b. Create bus buddy system for students using public transit.
    - c. Look into King County van pools and drop-off sites.
    - d. Come up with strategy to create more online and hybrid courses.
    - e. Will North/Central faculty and staff be able to work from South campus?
