At the end of the course the student will:

1. Demonstrate mastery over the factual information contained in this course.

2. Discuss the basic concepts that form the foundation of the study of human sexuality.

3. Communicate how the information found in this course relates to "real life" situations.

4. Analyze basic theories and scientific data in sexology by breaking such theories and data into parts that aid in an understanding of the "whole" of human sexuality.

5. Illustrate the ability to integrate this material into a personal and world perspective, and create new understandings and perspectives.

6. Evaluate and critique (in a scholarly way) human sexuality literature.

Explain the student demand for the course and potential enrollment:

This course traditionally has healthy enrollment. Expanding the offering to hybrid option can allow for schedule accessibility for students and instructors.

Explain why this course is being revised:

This course is requesting revision due to change of mode, adding Hybrid. Given that we have prior approval for fully face to face and fully online, this is the next logial approval, as it will allow students to take this course with face to face instruction, with the leniency of time scheduling as well as online content delivery.
